

Responding as Disciples Works daily. But until they do them in ways showing that they love God above all, they have not yet discovered stewardship as a way of life.

> We are all at different stages of our understanding of stewardship and our willingness to embrace stewardship as a way of life. Yet this much is clear: as baptized Catholics, each of us can grow closer in our relationship with Jesus and His Church by consciously and prayerfully considering our actions like disciples. God gives us prayer, service and tithing to bring us closer to the living Jesus - to enter into deeper communion with Him by extending His mercy to others. By extending His love, we become more and more the person God created us to be and, at the same time, live for His glory.

> Each of the over 2600 registered families at Our Lady of Grace is called to make lesus Christ known and loved. As we annually renew our commitment to stewardship, we are asked to respond as disciples, by looking inward and examining our lives, taking time to recognize our gifts, discerning how those gifts may change over time and, in the process, reflecting on how God wants us to use such gifts to become lights of the world (cf. Mt 5:14).

What is Stewardship? Stewardship is the intentional, grateful and loving response of a Christian disciple – a way of life that recognizes, receives and shares God's gifts and charisms for the good of all, making Jesus Christ known and loved.

Stewardship of PRAYE How do you spend the 168 hours in your week?

Are you encountering Jesus in your daily life?

Are you taking time to talk with Jesus in prayer, to speak with Him as you would a friend?

Are you seeking His truth through reading the scriptures?

Will you make Him first on your priority list so that you are able to share with others from the graces He has given you?

Do you share the gift of yourself with Him?

An intimate friendship with Jesus is cultivated through prayer, where we answer God's call to love with our whole heart, mind and person by expressing our gratitude to Him for all He has given us, especially His son, Jesus. Praying regularly can be challenging. But just as we manage our money and time to make our lives run more smoothly, making a personal pledge to spend time and attention in prayer is critical to help us see the presence of God in our lives as we grow in relationship

Sunday and Holy Day - daily Mass once a week or more frequently

Keep Sunday holy

refrain from unnecessary events or work

Spend personal time with Jesus daily 5 minutes - 10 minutes - 30 minutes - or more

Pray as a family daily

Read and meditate on scripture (Lectio Divina) weekly - daily

Practice corporal works of mercy by: visiting someone who lives alone, or is homebound or incarcerated; feeding the hungry; helping to build a house for those in need; serving at a charitable organization.

Gospels Jesus speaks often about money, possessions and our need to share in abundance the gifts God has given us. Sadly many people measure their lives by the goods that they acquire; they are owned by their possessions. Those responding as disciples, in contrast, plan and prioritize their lives as stewards, knowing that whatever they have is held merely in trust from God. They recognize an inherent need to give in ways that have nothing to do with the need to receive in return. In giving their first fruits, they not only help make possible the work of God that is happening all around them, but give powerful expression to the place of God in their lives. They live knowing that their heart lies where their treasure (cf. Mt 6:21).

What is your **giving** goal? Most parishioners are not in a financial position to start out tithing (giving) 10%; however, over time, by adding a percentage increase each year, the 10% can be reached.

Please prayerfully consider a gift to the Parish Stewardship fund that is honest, consistent and generous, one that moves you further towards a tithe of 10% by:

Becoming a new giver making a weekly donation of one hour of pay per week.
